The following is a summary of the requests for funds made by the 92nd (2026) General Assembly to the churches for 2027, and directions on where to send those funds.

(1) **GENERAL ASSEMBLY OPERATION FUND:** The Assembly requested the churches to contribute **\$18.00 for each communicant member** to the 2027 General Assembly Operation Fund.

**Contributions to the General Assembly Operation Fund** should be made payable to *The Orthodox Presbyterian Church*, marked “GA Operation Fund,” and sent to 607 Easton Rd., Bldg. E, Willow Grove, PA 19090-2539, after January 1, 2027.

(2) **GA TRAVEL FUND:** The General Assembly requested the churches to contribute **\$18.00 per communicant member** to the 2027 General Assembly Travel Fund. This fund pays for the travel expenses of commissioners to the 2027 General Assembly.

**Contributions for GA Travel Fund** should be made payable to *The Orthodox Presbyterian Church*, marked “GA Travel Fund,” and sent to 607 Easton Rd., Bldg. E, Willow Grove, PA 19090-2539, after January 1, 2027, but before the 2027 General Assembly which is scheduled to be held June 9-15, 2027.

(3) **WORLDWIDE OUTREACH:** The General Assembly approved the following Worldwide Outreach program for 2027 to support the combined ministries of the Committees on Foreign Missions, Home Missions, and Christian Education.

**Contributions for the Worldwide Outreach** should be made payable to *The Orthodox Presbyterian Church*, marked “Worldwide Outreach,” and sent to 607 Easton Rd., Bldg. E, Willow Grove, PA 19090-2539. All contributions for WWO for 2027 need to be received by December 31, 2027.

(4) **DIACONAL MINISTRIES:** The Assembly requested the churches to support the work of the Committee on Diaconal Ministries in 2027 at the suggested rate of **\$30.00 per communicant member** for the General Fund.

**Contributions for Diaconal Ministries** should be made payable to *The Orthodox Presbyterian Church*, marked “Committee on Diaconal Ministries,” and sent to 607 Easton Rd., Bldg. E, Willow Grove, PA 19090-2539.

(5) **MINISTERIAL CARE:** The Assembly requested the churches to support the work of the Committee on Ministerial Care in 2027 at the suggested rate of **\$25.00 per communicant member** for the General Fund.
